## Terms and Conditions (Excerpt)

### 1. School Year

The Academy's school year aligns with the public-school year in Zollikon. Lessons start in the first week of the school year. Lessons are canceled on public holidays and are not rescheduled.

### 2. Lessons

The lesson offerings are aimed at children, adolescents, and adults:

### 3. Registration

Registration is done in writing via online registration at [www.imuka.ch](http://www.imuka.ch). By registering (basic contract), the signatory acknowledges the academy rules of the International Music and Art Academy IMUKA. Registration remains valid until a deregistration is made. Registration deadlines: May 31 for the first semester / November 30 for the second semester. In exceptional cases, admission can also occur during the semester.

### 4. Deregistration

Deregistration is only possible at the end of a semester by adhering to the deregistration deadlines. Registration remains valid until a written deregistration via [email](mailto:info@imuka.ch) on [www.imuka.ch](http://www.imuka.ch) or mail is made. Deregistration deadlines: May 15 for the end of the second semester / November 15 for the end of the first semester. Courses and project weeks: Registrations for courses and project weeks are valid for the duration of the corresponding announcement. After their expiration, the student leaves the music school without deregistration unless a new registration occurs.

### 5. Tuition Fees

The tuition fees are detailed in the school tariff regulations. Tuition fees are billed per semester and are payable within 30 days. Every started semester must be paid for.

### 10. Inability to attend lessons

Inability to attend individual or multiple lessons must be reported to the teacher as early as possible. This also applies particularly to academy events such as project weeks and master classes. If music lessons are missed due to this, they will not be rescheduled.

### 12. Liability

> Liability and accident insurance are the responsibility of the course participants or their legal representatives. We recommend checking with your own accident insurance for coverage of possible injuries during dance lessons.

> The academy is not liable for the personal belongings and valuables of the course participants. It is not liable for theft, property damage, accidents, and injuries in and around the school.
